Let it be known to all those to whom these Presents come: This is your lawful notice that The Ohio Assembly is in session and the Ohio Trust has by operation of Law returned to the oversight and lawful possession of the naked Priority Credit Donors.

The Ohio Assembly has a Public Duty to Keep the Peace and Uphold the Public Law, as evidenced by our Peace Proclamation and Treaty.


